  - "Do not let unwholesome talk come out of your mouths, but only what is helpful for building others up according to their needs, that it may benefit those who listen." - Ephesians 4:29
- 4. Never go to bed at night angry with each other.
- 5. Forgive my spouse.
- 6. Visualize what our lives can be together.
- 7. Consider what God wants in this situation, not what you want.
- 8. Humble myself before my spouse.
- 9. Do not give up.
- 10. Pray together regularly.

### A Prayer for Commitment to Marriage
